  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: Nrs. 8,20,00,000.00
  - Minimum Work experience of similar size and nature: 1(one) number of hospital building/Health post building project with minimum value of Nrs. 8,75,00,000.00.
  - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a Building with 51 MT Reinforcement works
  - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a Building with 630 cum. of Concrete Works
