Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend on 29th November, 2021 (13th Mangsir 2078) on 01:00 hours at the office of Belaka Municipality, Rampur Udayapur. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security of above mentioned amount, which shall be valid for 30 days beyond the validity period of the bid.
