The bids will be opened in the presence of Bidders' representatives who choose to attend at 13<sup>th</sup> June, 2021 (30<sup>th</sup> Jestha 2078) on 01:00 hours at the office of Belaka Municipality, Rampur Udayapur. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
