

The bids will be opened in the presence of Bidders' representatives who choose to attend at **13th June, 2021 (30th Jestha 2078) on 01:00 hours** at the office of Belaka Municipality, Rampur Udayapur. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting mentioned above, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in dharauli account No. 0770040274200004 at Kumari Bank Ltd. Belaka Branch and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
